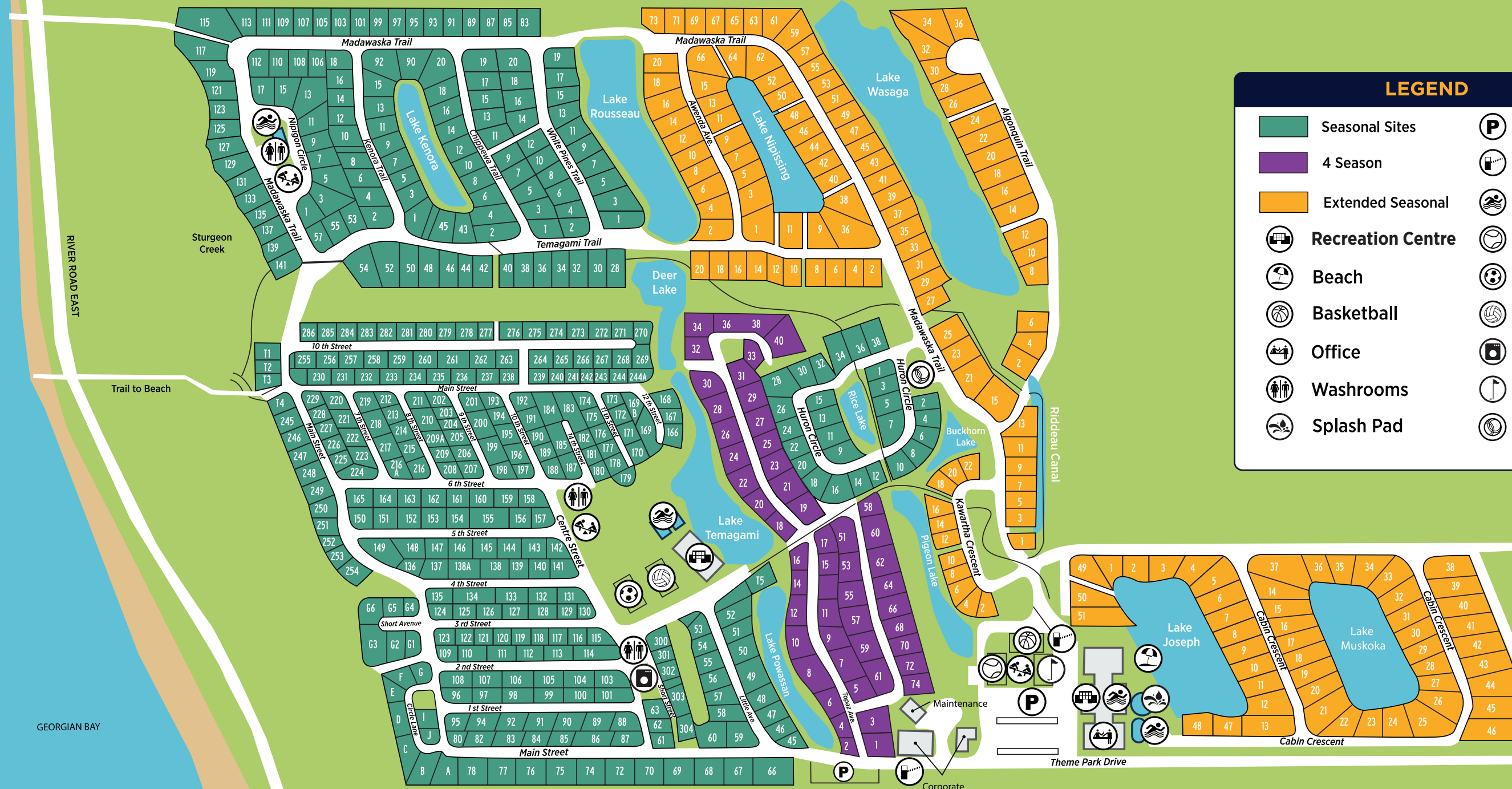

# Wasaga CountryLife Resort Guidelines

## Payment Method

Payments accepted in the Resort Office.  
Visa, MasterCard, & Debit. All rates are in Canadian Dollars.

## Vehicles

One to Two (1-2) vehicles only per site as driveway permits.  
Park in Visitor Parking for additional parking.

## Tents

No tents permitted.

## Campfires

Open wood burning fires permitted in designated pits or chiminea.  
Check fire hazard boards for status.

## Quiet Time

11 PM to 8 AM daily.

## Smoking

The use of tobacco and marijuana (including e-ciga-rettes and vapes) is not permitted in public areas of the Resort (including the beach). Where designated smoking areas do exist, they are restricted to tobacco only.
