Payment Method

Visa, MasterCard, & Debit. All rates are in Canadian Dollars.

Policy Cancellation Overnight RV Sites

If more than 7 days' notice is given, a \$20 administration fee (plus applicable taxes) will be charged. Less than 7 days' notice to cancel will result in the original deposit being forfeited.

Vehicles

Two (2) vehicle per site only.
Park in Visitor Parking for additional parking.

Tents

Tents are permitted in overnight camping areas and in the seasonal section with approval from park management.

RESERVATION RIGHTS & CANCELLATION POLICY

By completing this booking, you acknowledge and agree that Wasaga Pines may, in its sole discretion and to the fullest extent permitted by applicable law, refuse service or cancel any current or future reservation (including reservations made under different booking periods) at any time, with or without notice, and with or without cause. We do not cancel or refuse service for reasons prohibited by law.

If we cancel a reservation not due to your breach of our rules/terms, we will refund the amounts you paid for the cancelled stay. If we cancel due to your breach (including unsafe, disruptive, or abusive conduct, non-payment, misrepresentation, or violation of campground rules), refunds (if any) will be handled in accordance with our posted refund policy and may be reduced to cover fees, damages, or costs.

NOTICE TO USERS OF THE RESORT FACILITIES ASSUMPTION OF RISK AND WAIVER AND RELEASE OF CLAIMS PLEASE READ CAREFULLY These conditions will affect your legal rights.

"Activities" shall mean, without limitation, all activities in any way associated with or related to water sports, recreational vehicle camping, hiking, fishing and any recreational activities offered by Parkbridge Lifestyle Communities Inc. or any of its volunteer or community associations (collectively referred to as "Parkbridge"), including training and instruction, as well as but not limited to us of play structures, picnic areas, fields, sports fields, beaches, lakes, man-made lakes, swimming pools, parks, trails, walking paths, roads, grounds and parking lots. In consideration of Parkbridge allowing the RESORT USER onto its Property to use and enjoy the Property and to participate in Activities, the RESORT USER agrees as follows:

1. THE RESORT USER ASSUMES AND ACCEPTS, WITHOUT LIMITATION, ALL RISKS AND DANGERS associated with the RESORT USER'S use and enjoyment of the Property and participation in any of the Activities.
2. THE RESORT USER ASSUMES FULL RESPONSIBILITY for understanding and following the rules and safe practices associated with the use and enjoyment of the Property, participation in any of the Activities, and for his or her own personal safety.
3. THE RESORT USER WAIVES ANY AND ALL CLAIMS that he or she has or may have in the future against Parkbridge and its parent, subsidiaries and affiliated entities and their respective directors, officers, employees, agents, volunteers, contractors and assigns arising from or connected, directly or indirectly, with the RESORT USER'S presence at, or use and enjoyment of, Parkbridge's Property, and the RESORT USER'S presence at, or participation in, any of the Activities.
4. THE RESORT USER RELEASES Parkbridge from any and all liability for any loss, damage, injury or expense that he or she may suffer or incur by reason of his or her presence at, or use and enjoyment of, the Property, and presence at, or participation in, any of the Activities, due to any cause whatsoever, INCLUDING NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY DUTY OF CARE, INCLUDING ANY DUTY OF CARE OWED UNDER ANY APPLICABLE OCCUPIERS' LIABILITY LEGISLATION ON THE PART OF PARKBRIDGE, OR OTHER PARTICIPANTS, OR ANYONE ELSE.

Campfires

Open wood burning fires permitted in designated pits or chiminea.
Check fire hazard boards for status.

Quiet Time

11 PM to 8 AM daily.

Smoking

The use of tobacco and marijuana (including e-ciga-rettes and vapes) is not permitted in public areas of the Resort (including the beach). Where designated smoking areas do exist, they are restricted to tobacco only.

Speed Limit

The speed of any vehicle operating within the resort is restricted to posted speed limits.

Overnight RV Site Pet Policy:

Up to two well behaved animals per site are welcome in the Resort. All pets must be on a leash at all times when outside the unit and all pet waste (including in your site) must be picked up immediately. Pets are not to be left unattended at your site. Excessive noise, allowing pets to roam off leash or not picking up after your pets could result in you being asked to leave the Resort. Pets are not allowed in any buildings, in the playground area, or other camper's sites.

NOTICE OF PHOTOGRAPHY & RECORDING:

The Resort User(s) acknowledges that Parkbridge occasionally has a photographer and/or videographer on site to take photos and video for advertising, promotion, social media and other related uses, and that by entering the premises or any on site event, the Resort User(s) will be entering an area where photography, audio and video recording may occur. The Resort User(s) hereby:
