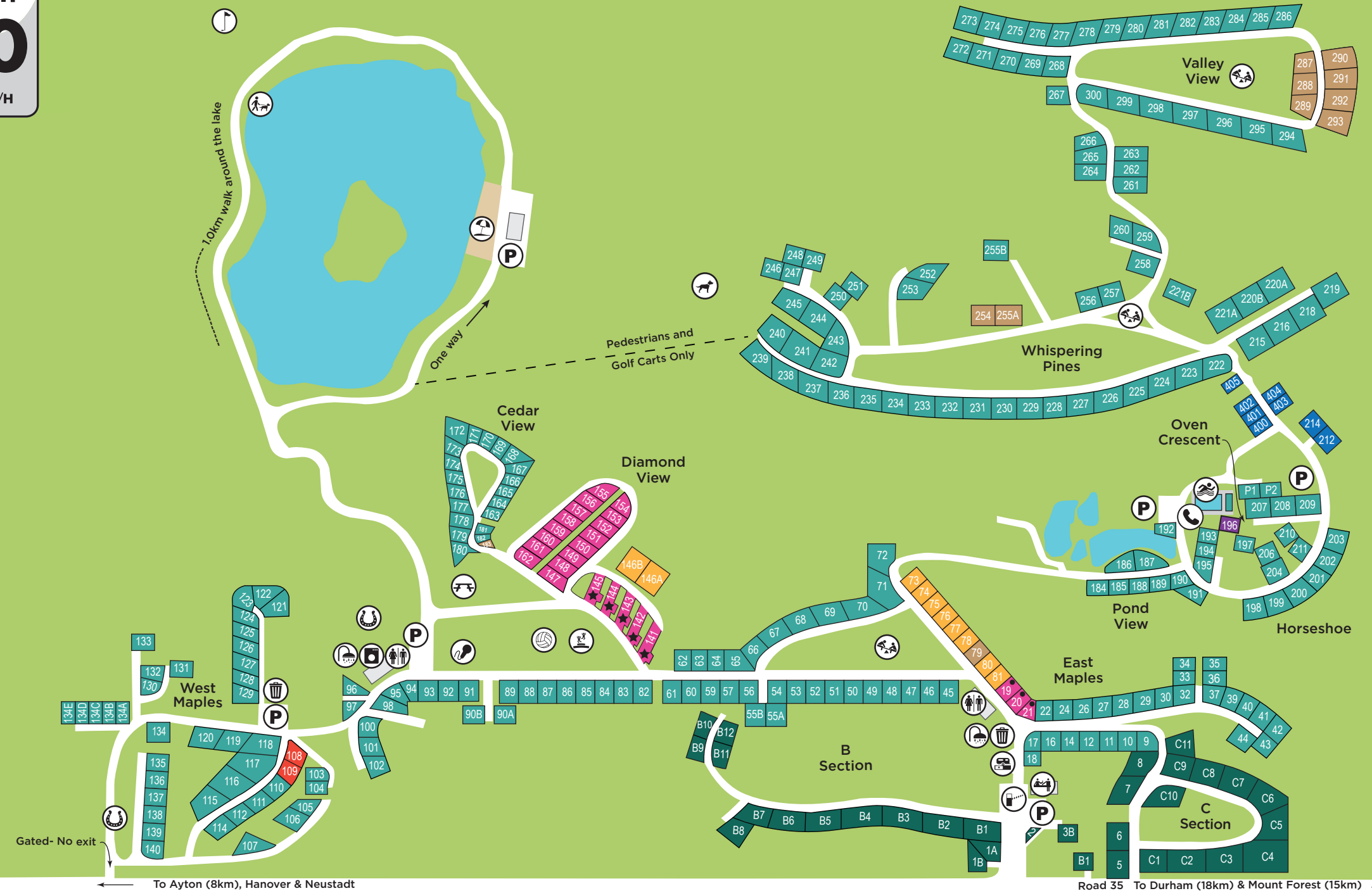

Booking

Reservations taken all year round. Guests can choose site if available. Guests provided with site number on completion of booking.

Cancellation Policy Overnight RV Sites/Tenting

If more than 14 days' notice is given, a \$20 administration fee (plus applicable taxes) will be charged. Less than 14 days' notice to cancel will result in the original deposit being forfeited.

Cabins

If more than 14 days' notice is given, a \$20 administration fee (plus applicable taxes) will be charged. Less than 14 days' notice to cancel will result in the original deposit being forfeited.

Deposit

Deposit taken on booking reservation via credit card.

Payment Method

Visa, MasterCard & Debit accepted. All rates are in Canadian Dollars.

Deposit Structure

1 - 3 nights: 100%

4 - 14 nights: 50%

15+ nights: 30%

Minimum Stays

Peak Season

Weekdays - 1 night

Weekends - 2 nights

Long Weekends - 3 nights

Shoulder Season

No minimum - exception for Long Weekends, must equal 3 nights.

Quiet Time

11 PM to 8 AM daily.

Check In / Check Out

Check in 1 PM

Cabin Rental Check in 4 PM

Vehicles

One (1) vehicle per site only. The speed limit is 10 km/h.

Tents

One extra tent per RV site - if in the same party. One tent per Tenting Village site.

Pets

Well behaved pets are welcome. Pets must be on leash at all times. Excessive noise or allowing pets to roam off-leash could result in you being asked to leave the Resort. Dogs are not permitted on the sandy swimming beach. There is a posted dog friendly area in the North West corner of the Lake.

Campfires

Open wood burning fires and fireworks are not permitted.

No Smoking

The use of tobacco and marijuana (including e-cigarettes and vapes) is not permitted on the beach, in any common areas, or in Rental Cabins. Where designated smoking areas do exist, they are restricted to tobacco only.

Additional

The beach is glass free.

Sound equipment is not permitted.

Rate Structure

Based on two (2) person occupancy, limit of five (5) adults (18+ years) per site. Additional Persons: 6 years and older \$4.00. Children under 6 years old are free.
